Summary of Changes to IFB-CO-115286-MCAFEE:

1. Book I: Bidding Instructions

The following sections are hereby revised by this letter – no updated document is provided:

- a. Section 2.10, Bid Validity Bidders shall be bound by the term of their Bid for a period of ninety (90) days starting from the Bid Closing Date specified in paragraph 2.3.1 above until 18 December 2020.
- b. Section 3.1.5 Bidders are advised that the Purchaser reserves the right to incorporate the successful Bidder's offer in whole or in part by reference in the resulting contract. This section is hereby deleted.

2. Book I, Bidding Instructions, Annex A-3, Bidding Sheets

- a. This amendment removes CLIN 4, *Enhanced Success Plan*, from the 3-year Optional Period, 2022-24. Please note that CLIN 2, *Enhanced Success Plan*, remains included in the Base Period (2021).
- b. The Excel file provided with the IFB, "03_ IFB-CO-115286-MCAFEE-Book I-Bidding Sheets-Schedule of Supplies and Services" is replaced by the amended file enclosed with this IFB Amendment.
